1. The joining fee is a one time, non-refundable fee for all new members payable upon application and as long as the membership stays constant. If you cancel your membership and, at a later date, wish to have a new membership, you will be required to pay a new joining fee. **A 30-day written cancellation must be completed by the Member and membership cards returned for Bank Drafts to be terminated. This is the responsibility of the Member. Members may send a fax to (843) 770-0875. Members who cancel by fax are strongly encouraged to call the Member Services office at (843) 522-9622 to confirm receipt of faxes. The YMCA will not assume liability for more than two (2) months for which the YMCA has a record of receipt. Please verify the accuracy of payments from your account to the YMCA on a monthly basis.**

2. ALL ACTIVE-DUTY MILITARY WILL HAVE THEIR JOINING FEE WAIVED. (Our way of saying "Thank You" for your service.)

Youth: Any youth 12 & under may use the pool, gym and youth locker rooms with parental supervision.

Teen: Any teen (ages 13-18) may use the pool, gym, and youth locker rooms. Teen's ages 13-14 may use the fitness center only if accompanied by their parent or legal guardian.

College: Any person taking 6 credit hours or more from an accredited college or university. A current class schedule and ID with family address must be presented within one week of membership and at the beginning of each semester thereafter. Failure to provide information will result in membership being automatically upgraded to adult membership. It is the member's responsibility to provide this information. This is until 24th birthday only.

Adult: Any individual 19-61 years of age. Member must notify Front Desk upon turning 62 for Senior Adult membership rate adjustment.

Junior Family (No children): Any two adults living at the same address.

Family: Offered to anyone presenting themselves as a family unit of 2 adults residing at the same address with dependant children up to the age of 23 if those children are still in school. Dependant children need not reside at the same address full time. (Children must be 3 months - 18 years, full time students until age 23, a current class schedule and ID with family address must be presented within one week of membership and at the beginning of each semester thereafter). (Those who were originally covered under family memberships and are still living at home should ask the Membership Office about waiver of joining fee when setting up their own membership.)

Senior Adult (62+): Any individual age 62 years and over.

Senior Family (No children): Any two adults 62+ living at the same address. Only one must be over the age of 62, the other must be over 18.

Single Parent Family: Any adult 18+ with children who are claimed on their tax return and living at the same address.

The YMCA of Beaufort County recognizes the importance of the family unit in the lives of children and adults. Proof may be required before adult children, grandchildren or foster children can be added to your membership.

Family: Offered to anyone presenting themselves as a family unit of 2 adults residing at the same address with dependant children up to the age of 23 if those children are still in school. Dependant children need not reside at the same address full time. (Children must be 3 months - 18 years, full time students until age 23, a current class schedule and ID with family address must be presented within one week of membership and at the beginning of each semester thereafter). (Those who were originally covered under family memberships and are still living at home should ask the Membership Office about waiver of joining fee when setting up their own membership.)

Single Parent Family: Any adult 18+ with children who are claimed on their tax return and living at the same address.
